DESCRIPTION OF WHAT YOU WILL BE SELLING, BE SPECIFIC _____

1. Vendor spaces are one **12 x 12 space outside for \$25** (you will need to bring your own EZ-up, table and chairs). If more space is required, there will be an additional fee (contact the event coordinator).
2. There will be a **\$25. fee applied to all returned checks** and you will need to come in and pay in cash to keep your space.
3. Vendors must **set-up on Saturday between the hours of 7:30 am and 8:30 am**. Vendors arriving late are not guaranteed close access to their space. If you choose not to participate, you shall forfeit your vendor fees.
4. Make sure your EZ-up is secured with **sand bags or other heavy tie downs**. We do get wind in the PASS area.
5. All vendors must have in their possession a State Board of Equalization permit number and a Beaumont City Business License.
6. You are responsible to leave the area as clean as it was when you arrived.
7. **All space fees are non-refundable.**
8. The Beaumont-Cherry Valley Recreation and Park District (BCVRPD) will review all applications, on a first come first serve basis. Payment must be enclosed before any consideration will be taken.
9. Unsigned or incomplete application will not be honored and a space will not be reserved.
10. After the application is signed and you receive your confirmation, goods for sale CANNOT be changed, without the BCVRPD's written approval.
11. All checks or money orders will be returned promptly if the application is rejected.

12. Undesirable toys such as: lasers, swords, silly string, stink-bombs and cap guns are **prohibited**. Any questionable items should be approved before hand to avoid any dispute during the Festival.
13. There is **no electricity provided** for this event.
14. **Tear down will be at 2:00 pm.** There will be no early tear-down, **NO EXCEPTIONS.**

AGREEMENT, WAIVER, AND RELEASE (required by CAPRI)

In consideration for being permitted by the BCVRPD to participate as an instructor, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said activity. This release is intended to discharge in advance the District (its officers, employees, and agents) from any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above persons or entities free and harmless from any loss, liability, damage cost, or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in said activity.

I have carefully read the agreement waiver, and release above and fully understand its contents. I am aware that this is a release of liability and a contract between myself and the district and I sign it of my free will.
