How and When to Enter

Send or hand deliver a completed application form with your names, addresses, and daytime telephone numbers where you can be reached along with DVD, essay, photograph and a self addressed stamped envelope in a 5 x 7 sealed envelope. Photographs, DVD's and essay remain the property of Beaumont-Cherry Valley Recreation and Park District.

Deadline

All entries must be submitted no later than March 9, 2012 at noon to the Beaumont-Cherry Valley Recreation and Park District office, 390 W. Oak Valley Parkway, Beaumont, CA 92223.

Limit one entry per couple.

All entries become the property of BCVPRD. Sponsors are not responsible for mail that is lost, stolen, late, illegible, incomplete, damaged, mutilated, misdirected, altered, tampered with, or postage-due.

Eligibility and Guidelines

Entrants must be 18 years of age or older as of June 1, 2012 and must be legal residents of the United States. Contest is open to all legal residents in Riverside and San Bernardino Counties. This contest is geared towards single, unmarried people.



Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for Beaumont-Cherry Valley Recreation and Park District or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the contest or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter. "Immediate family members" shall mean parents, step-parents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

How and When Winners Will Be Selected

The winning couple will be selected by a panel of independent judges. The winners will be announced the week of April 2, 2012. The fortunate couple will win an outdoor wedding package at the new Franco Gardens at Noble Creek in Beaumont. The package includes donations from various applicable wedding vendors that will help defray the cost of a typical wedding. The Beaumont-Cherry Valley Recreation and Parks District will provide the outdoor wedding package and indoor reception facility at no cost for up to 6 hours.

The wedding will take place **on June 16th, 2012 (no exceptions)***.

All entrants will receive a certificate for a \$100 discount towards a booked wedding in the new Franco Gardens at Noble Creek in Beaumont, CA.

One Grand Prize winning couple will receive a wedding for themselves along with 100 guests (this includes bridal party, friends and family). The following wedding-related expenses will be donated:
